Summary of 2018:

The Norwegian Chinese Chamber of Commerce experienced an energetic year in 2018.

First of all, we are very happy for the normalization of bilateral relations between China and Norway since end of 2016. The level of activities in the form of Members' Meetings has continued to increase, in addition to an increased number of meetings with the Chinese delegations.

In 2018 a total of 497 persons attended NCCC's five Members' Meetings during the year.

Topics we have focused on at our meetings in 2018 include CHINA AND THE NEW ECOMONY Digitalization, Opportunities between China and Norway, Trade & Aquaculture, International Transport and Communication - Opportunities between China & Norway, Cleantech and renewable energy in China, and Chinese Tourism in Norway.

NCCC has arranged and participated in encounters with diplomats and business delegates during the year, including the Business Delegation with King and Queen's visiting in China October 2018. The CIIE China International Import Expo CIIE in Shanghai as Co-organizer.

Additionally, NCCC has arranged Matchmaking Meetings between our corporate members and the Chinese entrepreneurs.

NCCC has kept up its work and high activity level of facilitating Norwegian-Chinese business relations in 2018.

Administration:

The daily administration of NCCC, including accounting, website and communication was taken care of by Elise Chen, as Managing Director, with assistance from Pepwork Design and Accounting manager Ms. Chenyan Li, supporting staff Dragana Paulsen and Taotao Liu.

Ms. Elise Chen has the main responsibility for promoting the NCCC organization and organizational development, and is the main contact person for NCCC members.
