Summary of 2020:

2020 has certainly been a special year. Despite the extraordinary circumstances NCCC has prevailed and sought to adapt. Following our kick-off and Chinese New Year seminar in cooperation with the Singapore Norway Chamber of Commerce, we have gone digital and will continue to do so until we can all meet again in person. Our first digital event took place in the spring, where we arranged a webinar for exchange of valuable experience in relation to handling and treatment of Covid-19 for doctors and specialists from Oslo University Hospital and Shanghai Fudan University Hospital. NCCC webinars in the autumn have been focus on business status between Norway and China in 2020, taking into the account the prevailing Covid-19 situation and among other things such factors as the upcoming US elections.

During the visit by Chinese Foreign Minister Wang Yi in August, we were pleased to notice that amid the epidemic, early completion of the China-Norway Free Trade Agreement (FTA) negotiations is of great significance to advancing economic and trade cooperation between our two countries. NCCC will continue our best effort to promote and protect the friendly relations between China and Norway together with our members.

In 2020 a total of 428 persons attended NCCC's five Members' Webinar.
